- 1. I own the web site names: HomelessHelpers.com | ReEntryHelpers.com | IndianaHelpers.com | IndianaReEntry.com & HomelessReEntryHelpers.com they are currently all pointing to the same place. The only name I am promoting now is the ReEntryHelpers.com but I want to change that to IndianaHelpers.com.
- 2. My (Don's) personal goal is to get every potential mentor, volunteer, teacher, tutor, instructor, Organization, employers and other business leader I/we can think of to this meeting/conference that can hear the D.O.C. ReEntry/PREF story and what PREF needs to make it successful.

Needless to say I would also expect case workers, specialists, probation officers, parole officers, etc. to be there too.

During and after the conference it should be PREF's "team members" that are responsible for convincing the attendees on how they can help and/or work together with PREF. I am not qualified to pick and choose anyone for the speakers – that would be DOC's & PREF's job.

- 3. The main goals of this proposed conference is to secure faith, and community based persons, and/or organizations help D.O.C., PREF (and later PFC, Pendleton, etc.) succeed:
 - a. Mentors
 - b. Volunteers
 - c. Teachers
 - d. Tutors
 - e. Instructors
 - f. Social Service Organizations/Partners
 - g. Employers
 - h. Business/Private Sector Partners

Collectively the above, with the help of existing mentors, volunteers, etc. will help PREF find solutions on finding jobs, housing, education, etc. to build on what has already been started at PREF.

We want this conference to be a working conference with actual offenders, actual mentors, actual teachers and actual organizations, etc. that are already making a difference at PREF. This will be a show-and-tell conference. PREF will inform the attendees of the conference on the benefits of helping out in our community and telling them what PREF has, and can accomplish if it is properly implemented with all the tools it needs, letting them know that PREF can only achieve its goals with community involvement.

Remember, ever body wants to be part of a successful venture. We need to make PREF a project that people can participate in, that is successful, of which they can be proud to be a part of. We have to show them that even though PREF has only been in operation for less than two years, it already has many successes, and explain to them why it could even be a bigger success if they and/or their organization would get involved.

Our goal (this conference) will be to secure "existing" private service organization, that are already working with; the homeless, e-offenders, veterans, etc. Organizations that would be interested in working with the PREF residence "inside the fence" as well as "outside the fence" on a daily/weekly basis so they can create a built-in client base so when the resident leaves PREF they already have someone and somewhere to get help from that they already know.

4. We do not want this conference to be just another information conference, where people stop, look, listen, pick up brochures, swap business cards, file the information away, and do nothing.

We will be there taking applications and telling them about the screening process they have to go thru and asking them when, and where they can start mentoring, volunteering, teaching, etc.

- 6. If we can get enough positive responses to "fill a room" we can then decide when and where to have it.
- 7. Then, we need to make up Flyers, Posters, Brochures, etc. for the Conference and get the word out to the media and everyone else we can think of.

- 8. I would suggest that this Conference not be for the general public at this time (but I'm still open for suggestions). It should be for existing private and government social service type people and organizations, and community business leaders. I believe that there are enough existing people and organizations out there, that if they were to be made aware of what PREF is and what they can do, would come forward and help fill the current void. It will be the conferences job to "get the word out".

I think (and I think you do to) the private sector is the "missing link" to this and any successful reentry program.

9. Title and Theme of the proposed conference:

a. Ex-Offenders – A Conference on Re-Entry

"Looking for Solutions thru Community Networking & Teamwork"
